RESPONSIBILITY OF DISTRICT AND BOARD COUNSELOR EXPENSES

GOVERNORS, GOVERNORS-ELECT, and DISTRICT SECRETARIES, please note that in the past we have received questions regarding the district's responsibility toward expenses for a Board Counselor to attend the district convention.

Kiwanis International Board Procedure 107 F and G states: **Expenses:** The transportation expense for the Counselor to attend district functions shall be borne by Kiwanis International...The district should bear the cost of housing, meals, and other expenses related to the Counselor's responsibilities. **Spouses:** If invited by the district, spouses are welcome to attend district visits as part of district counseling assignments and Kiwanis International shall pay the transportation expense (limit of one trip per assigned district).

We hope this will clear up any questions; however, please let me know if you still are unsure of anything regarding this matter.

TENTATIVE DATES FOR THE 2010-11 BOARD MEETINGS AND OTHER IMPORTANT DATES

To avoid conflicts for Board Counselors attending district conventions, Board Procedure 250.2 states the following:

250 - District Conventions

250.2 - Date

The district convention shall not be held between the second week of April and the second week of May, so that it will not conflict with the meeting of the International Council or the International Board Meeting traditionally held during that time period and so that schedule conflicts with the district's Board Counselor will be avoided. (5/94) (4/97)

The district convention should not be less than two (2) days or more than three (3) days in duration. (5/93)

Not later than October 31, annually, the district secretary shall inform the Chief Executive Officer of the dates and location of the next annual district convention. A summary of convention dates shall be provided to the International President-Elect by December 15. (6/91)

GRADUATED ENROLLMENT FEE SCHEDULE

Just a quick reminder that the new graduated new member enrollment fee goes into effect on April 1, 2010. Below is a copy of that schedule. **This means clubs will no longer pay a flat fee of US\$50 (Tier A), US\$25 (Tier B), or US\$15 (Tier C).**

What you should know:

- The new fee applies to all clubs in Kiwanis—Tiers A, B and C.
- The fee will be based upon the date the new member is entered at Kiwanis. So, if a club sends an “add” in January for someone who joined two months ago, they will be charged the January rate. The graduated enrollment fee brings the member into Kiwanis, until the club is billed in October 2010.
- Districts will decide whether to implement a similar fee structure. Kiwanis International will continue to charge the current fee, if applicable.

• The attached rate applies only to new members of existing clubs. The current rate for charter members of a new club remains in effect. Members joining a new club after the charter presentation will be charged the new member fee for an existing club.
